RECOMMENDATION: That the City Council (i) open the public hearing to accept comments on the City's proposed submittal of an application in response to the 2020 State Community Development Block Grant (CDBG) Notice of Funding Availability (NOFA); (ii) adopt Resolution No. 2021-08 approving an Application for Funding for up to \$471,928 and the execution of a Grant Agreement and any amendments thereto from the 2020 Community Development Block Grant Program-Coronavirus Response Round 2 & 3 (CDBG-CV2&3) NOFA dated December 18, 2020; (iii) determine that federal Citizen Participation requirements were met during the development of the application; and (iv) authorize the City Manager, or designees, to transfer or modify budget amounts and activities as necessary to fully expend CDBG Program funds and to execute loan documents, fund requests, and other required reporting forms.
