# **DEPARTMENT REPORTS**

ITEM J-1 - INFORMATION ONLY - New City Website

Assistant City Manager Steve Carrigan provided an overview of the City's new website.

ITEM J-2 - ADOPTED - Adoption of Annual Investment Policy

The Council by motion of Mayor Pro Tem Ontiveros approved Resolution No. 4363 adopting the City of Sanger's Investment Policy for fiscal year 2012/2013. The motion was seconded by Councilmember Nielson and unanimously approved.

ITEM J-3 - APPROVED - Authorized Signatories on Bank/Investment Accounts

The Council by motion of Mayor Pro Tem Ontiveros approved Resolution No. 4364 to authorize change in signatories on various financial bank accounts and designate certain City Officials with signatory authority. The motion was seconded by Councilmember Castellano and unanimously approved.

ITEM J-4 - INFORMATION ONLY- May Monthly Financial Review

Finance Director Debby Sultan provided a monthly financial review for May 2012.

# ITEM J-5 - ACCEPTED - Grant Acceptance for \$10,000

The Council by motion of Councilmember Nielson accepted the grant from Fireman's Fund Insurance Company in the amount of \$10,000 and authorized the City Manager to complete the necessary paperwork for acceptance. The motion was seconded by Mayor Pro Tem Ontiveros and unanimously approved.

ITEM J-6 - APPROVED - Contract with Social Vocational Services

The Council by motion of Mayor Pro Tem Ontiveros authorized the agreement between Social Vocational Services and the City of Sanger for park maintenance and authorized the City Manager to sign the required documents. The motion was seconded by Councilmember Ruiz and unanimously approved.

ITEM J-7 -AWARDED - Replacement of Granular Activated Carbon at Well 2A and Well 14 Water Treatment Plants

The Council by motion of Mayor Pro Tem Ontiveros awarded a bid to Calgon Carbon, Inc. in an amount not to exceed \$155,248 plus tax to replace the granular activated carbon at Well 2A and Well 14. The motion was seconded by Councilmember Ruiz and unanimously approved.

ITEM J-8 - APPROVED - The Sanger Kings River Access Park Project

Public Comment was received from Ed Cuadros, Don Steinhauer, Karen Steinhauer.

The Council by motion of Mayor Pro Tem Ontiveros accepted the preliminary Site Plan Exhibit, authorized the City Manager to start negotiations of a Memorandum of Understanding with Kings River Conservancy and authorized the City Manager to sign grant application and related documents with the State Department of Boating and Waterways and requested that local hiring preference be utilized wherever possible with this project. The motion was seconded by Councilmember Ruiz and unanimously approved.

ITEM J-9 – AWARD OF CONTRACT- Reconstruction of Oatman and Tait Avenues from 5<sup>th</sup> Street to Hill Avenue

The Council by motion of Councilmember Ruiz awarded the contract for reconstruction of Oatman and Tait Avenues from 5<sup>th</sup> Street to Hill Avenue to R.J. Berry Jr., Inc., P.O. Box 468, Selma, CA 93662 in the amount of \$463,218.12 and authorized the City Manager to sign contract documents on behalf of the City and approved a construction contingency for change orders in the amount of \$46,300 (10%) for this project. The motion was seconded by Councilmember Castellano and unanimously approved.

ITEM J-10 - APPROVED - Budget Amendment for the Purchase and Installation of Two Banner Support Poles Across Academy Avenue North of Jensen Avenues

Public comment was received by Ed Cuadros.

The Council by motion of Mayor Pro Tem Ontiveros adopted Resolution No. 4365 approving a budget adjustment and authorizing the expenditure of General Funds, in the amount of \$30,000 for the purchase and installation of two (2) metal banner poles on Academy Avenue north of Jensen Avenue. The motion was seconded by Councilmember Ruiz and unanimously approved.

### CITY MANAGER/STAFF COMMUNICATIONS

City Manager Brian Haddix commented on: the success of the National Night Out event at the Sanger Park; plans to partner with the Chamber of Commerce in securing a hospitality kiosk with the National Parks; the progress of the Strategic Plan.

### MATTERS INITIATED BY CITY COUNCILMEMBERS

Councilmember Ruiz asked that staff respond to Ed Cuadros' inquiry about the well at Greenwood Avenue.

Councilmember Castellano thanked public safety staff for the successful National Night Out event and asked Chief Rodriguez if the Department needed a second K9 unit.
