A. CALL TO ORDER

E. CITY ATTORNEY REPORT FROM CLOSED SESSION

City Attorney Scott Cross reported that no action was taken during closed session. The Council directed the City Attorney to establish a process for the appointment of the Interim City Manager. Interviews will be conducted with selected candidates in the near future, probably early next week, but the date has not yet been set. The Special Meeting will be properly noticed.

Council Member Pacheco commented that there is a lot of gossip going on and assured the Sanger community that he and the Council are trying to do the right thing. He stated that he will be participating in interviewing candidates for the Interim City Manager and to trust that the Council is looking at qualified candidates.

Council Member Ontiveros commented that there seems to be a lot of propaganda going on about the Interim appointment and asked the City Attorney to provide information on how the candidates have been identified.

Attorney Cross stated that the majority of candidates were obtained through the League of California Cities.

Council Member Garza commented that he will represent his district to the best of his ability and stated that his District has been neglected for some time. He mentioned that he will fight for his district needs which may differ from others, but that does not mean we can't respect each other.

Mayor Pro Tem Cantu commended that the council members are elected to represent their respective Districts and that together we will move Sanger forward. He also commented that the Council is following protocol and procedures and speaking on behalf of the whole Council, they are looking forward to bringing someone on board that is educated, has strong leadership skills and can be a team builder.
