Fred Heisman commented on extending sewer service on Academy Avenue to SR 180 in an effort to attract more businesses.

Osvaldo Vera commented on the use of marijuana being the number one problem and an epidemic in the US.

G. WORKSHOP

1. SUBJECT: FY 2016/2017 Budget.

Staff presented a budget workshop for the 2016/2017 fiscal year.

Public comment:

Kevin Carter inquired as to why, after the City indicated a surplus in the budget for the past two or three years, the City is now indicating a deficit.

City Manager Tim Chapa indicated that the deficit is an operating deficit and that revenues and transfers coming in are almost enough to cover the expenditures and where they are not enough, the fund balance would be used to cover the one time items.

Henry Provost inquired about the function of the Vactor truck and if it would be more appropriate to fund the purchase from the sewer fund as opposed to the disposal fund.

Public Works Director John Mulligan indicated that the Vactor truck is used for sewer and storm water because trash is affecting storm water drains and the fund balance is being used to purchase the vehicle.

Jeanne Adams encouraged the Council that before spending money for the dispatch center, the City should wait until after the November election which will determine whether Measure S will sunset or be renewed.

Donna Bailey commented that the City should fully fund the Police Department with police officers and a secretary before considering funding a dispatch center. She also inquired as to whether the dispatch center would include emergency calls to Fire.

Victor Ruiz commented that while he was a member of the Council he was an advocate of a dispatch center but that now it does not make sense and encouraged the Council to not make the dispatch center the number one priority.

Kathryn Pacheco, District 3, commented that the City cannot afford a dispatch center.

Henry Provost commented that Sanger would like to see a dispatch center but it is a financial deal and if Measure S does not pass the City will have to make cuts. He suggested increasing the tax base before deciding to spend a lot of money.

I. CITY MANAGER/STAFF COMMUNICATION

City Manger Chapa complimented the Department Heads on their budget presentations and thanked Interim Administrative Services Director Mike Hartman and Executive Assistant Kristina Chamberlin for their great work on developing the budget.

J. <u>MATTERS INITIATED BY CITY COUNCIL MEMBERS</u>

Council Member Garza commented that the Fresno Bee article regarding City Manager Chapa was exceptional and that it reflected well on him as a person and on the City of Sanger. He thanked City Engineer Josh Rogers for placement of the raised crosswalk at JFK Park.

Council Member Ontiveros thanked staff and City Manger Chapa for the development of the budget and that it was very thorough and better to follow and absorb. He reported that he had received calls from residents in east side of town about lower water pressure in the evenings.

Public Works Director Mulligan indicated that water pressure drops during watering nights and that the Department is moving forward on the EDA grant for a new water tank and on the rehabilitation of Well 14. He indicated that public messages will be sent out in an effort to educate the public about the water pressure.
