#### **DEFINITION**

Under the direct supervision of the Recreation Supervisor, the Site Supervisor is responsible for the implementation and organization of activities within the Summer Fun program, supervises Recreation Leaders, Junior Recreation Leaders and program participants and enforces all facility rules and regulations effectively.

#### **EXAMPLE OF DUTIES**

- Work with part-time staff to plan, organize and implement daily and weekly recreation activities for children in a wide variety of program areas.
- Report to jobsite 15 minutes prior to program's start time.
- Requisition all needed supplies and equipment on a weekly basis.
- Inspect all designated play areas and equipment for unsafe conditions prior to participant's arrival each day.
- Supervise and lead daily recreation activities such as arts & crafts, games, nature, music, etc.
- Ensure that all activities are conducted in a safe and healthful manner and that the site is left clean and ready for the next day's activities.
- Ensure that all daily and weekly reports are completed and turned in on time.
- Coordinate work schedules and review time cards before submitting to Recreation Division for approval.
- Record weekly attendance and prepare weekly calendar.
- Evaluate daily programs and part-time staff in the performance of their duties and responsibilities.
- Attend all designated meetings and trainings.
- Perform other related duties as required.

#### **DESIRABLE QUALIFICATIONS**

#### Knowledge of:

- Basic child guidance principles and practices.
- Effective supervision of youth activities or programs.

#### Ability to:

- Communicate effectively with children and adults.
- Understand and follow oral and written instructions.
- Plan and lead activities for children.
- Create and maintain enthusiasm among children.
- Be active, lift and/or carry equipment and supplies.

#### MINIMUM QUALIFICATIONS

- Must be at least 18 years of age.
- Minimum of two years of experience working with children between the ages of 5-12.
- Minimum of one year in a supervisory position in an organized recreation or childcare environment.
- Possess knowledge of the techniques and methods of planning recreation activities for children.
- First Aid and C.P.R. Certified before the start of the program.
- Completion of Mandated Reporting Training immediately after start date.

**TUBERCULOSIS TESTING:** Candidates selected to work in a position requiring contact with children must submit a certificate or notice documenting that within the last two years they have been examined and found to be free of communicable tuberculosis. The certificate or notice must be signed by a licensed examining physician or public health agency.

**CONCUSSION TRAINING:** Candidates selected to work in a position requiring contact with children are required to annually complete concussion training as required by CA AB2007. #### **SELECTION PROCEDURE:**

Applications received by the filing date will be reviewed for accuracy, completeness and job-related qualifications. Before starting work, applicants must present documentation of their identity and authorization to work in the United States.
