

SUBJECT: Approval and Recommendation to the City Council increased funding for the

Landscaping of Kelly Basin Park

### **RECOMMENDATION:**

That the Sanger Parks and Recreation Commission approves and recommends to the Sanger City Council the increased funding for landscaping Kelly Basin Park.

### **DISCUSSION:**

At the October 16, 2006 Parks and Recreation Commission funding of \$86,300.00 was approved to develop Kelly Park. Since that time issues have arisen that require extra funding for the park development. Specifically Irrigation standards, Concrete implementation, and Lighting, Mobilization, Traffic and Dust Control additions that were not originally included are now required.

Kelly Basin Park is located in "Service Area F" of the current Parks and Recreation Master Plan which calls for at least 2.5 acres of parkland space. Per the Conditions of Approval the Developer was required to dedicate 2.52 acres for a park/basin. A general landscaping description consists of 46 trees, Medium Fescue Mix, Irrigation system, Concrete Sidewalk, Decorative Lighting, Drinking Fountain are just a few of the amenities intended for the park.

### **FISCAL IMPACT**

The cost of the proposal is \$180,000.00 for the scope of work listed above. Monies are available through the Development Impact Fees Region Area 3 with a current balance of \$321, 956.30. Per Resolution 2935 of the Sanger City Council states that "the purpose of the Park and Recreation Public Service Facilities Fee is to finance the acquisition, construction and rehabilitation of new and existing parks and recreation facilities in the City of Sanger which are made necessary by new development.
