### **PROJECT PRIORITY LIST**

***The following is a listing of projects that have been chosen by the Parks and Recreation Commission as possible recommendations to the City Council for future consideration:***

- 1) Construction of a large regional park located in the City.**
  - The City needs to have a large regional park located in the City that can be used for different functions and accommodate a large amount of people.
  - Possibly on the west side of town.
  
- 2) Development of the 65 acres adjacent to the Kings River.**
  - This area should be a park that is reflective of the natural setting of the river, not an active park. Activities such as fishing, camping, horseback riding, educational opportunities.
  
- 3) Development of fairgrounds in the City.**
  - The City would benefit from a large area designated as fairgrounds to handle large formal events and annual fairs. This could be located more along the outskirts of town.
  
- 4) Updating current parks with additional features like PAR Courses and Tot Lots.**
  - Existing parks should be updated and upgraded. Each park should be kept to the best standards. Additions such as PAR courses and tot lots should be installed.
  
- 5) Finish the skate park.**
  - The Skate Park should be completed. Landscaping, lighting, signs, security.
  
- 6) Develop and expand the Veterans Park plan.**

- **The City should continue to work with Veterans groups to assure that a viable Veterans Park is constructed.**
- 7) Construct a new Community Center and pool.**
    - **A new Community Center should be constructed, possibly near a new regional park to accommodate the growing population.**
  - 8) Construct a new Senior Center.**
    - **A new senior center should be constructed near a new community Center to accommodate growth.**
  - 9) Bike trails to connect to other cities and establish bike trails.**
    - **Construction of bike trails to interconnect other local communities.**
    - **Helps to promote healthy living.**
    - **County is also looking into connecting cities with paths.**
  - 10) Fee schedule review and update for all rentable City owned facilities.**
    - **Review current facility rental fee schedule.**
    - **Review current policies**
  - 11) Additional playing fields.**
    - **Soccer**
    - **Baseball**
    - **Softball**
    - **Football**
