The City of Sanger is accepting applications from Sanger Community members to fill **one (1) Vacancy** on the **Public Financing Authority (“PFA”) for the Sanger North Academy Corridor Enhanced Infrastructure Financing District (“EIFD”)** with a term expiration of January 2024. The City of Sanger is seeking community members interested in making a difference in the community. Interested community members with expertise in business, finance, or community development, are encouraged to apply.

How to Apply

Applications are available at the City of Sanger City Clerk’s Office, 1700 7th Street, Sanger, California 93657 or online at www.cityofsanger.net. **The application deadline is 5 PM, Thursday, March 30, 2023.** Applications may be submitted electronically, by regular mail, or in person. Interviews are tentatively scheduled for the week of April 3, 2023. Appointment is tentatively scheduled for the City of Sanger City Council meeting of April 20, 2023.

What is PFA

The PFA is the governing board for the EIFD. The EIFD provides financing of public capital facilities and other specified projects of community wide significance that provide significant benefits to properties within the EIFD and the surrounding community. The board consists of five members, including three members of the City Council, and two members of the public. Applicants must be a registered voter, employee, or representative of a non-profit entity, educational institution, or other corporate citizen within the City of Sanger, or former elected or appointed City of Sanger representatives. All members must complete a Statement of Economic Interest when appointed and annually thereafter.

The board will meet annually, and as necessary to perform the responsibilities under the EIFD Law, including the review and approval of an Infrastructure Finance Plan, and the consideration of bonds to finance the projects defined by the Infrastructure Financing Plan.

This open recruitment is based on City of Sanger City Council Resolution No. 2021-67 which established a roadmap for the formation of the EIFD and PFA.

BACKGROUND

Responsibilities:

The Public Financing Authority (“PFA”) is the governing board for the Sanger North Academy Corridor Enhanced Infrastructure Financing District (“EIFD”). The EIFD provides financing of public capital facilities and other specified projects of communitywide significance, that provide significant benefits to properties within the EIFD or the surrounding community.

Requirements:

Registered voter, employee, or representative of a non-profit entity, educational institution, or other corporate citizen within the City of Sanger, or former elected or appointed City of Sanger representatives. All members must complete a Statement of Economic Interest when appointed and annually thereafter.

Membership:

Five (5) members, including: Three (3) members of the City Council, and Two (2) members of the public chosen by the City Council in accordance with City of Sanger City Council Resolution No. 2021-67.

Meetings:

Meetings will be held annually and as necessary to perform the responsibilities under the EIFD Law, including the review and approval of an Infrastructure Financing Plan (and any proposed amendments to that Plan), and the consideration of issuance of bonds to finance the projects defined by the Infrastructure Financing Plan.

Size:

Five (5) Members: Three (3) members of the City Council, and Two (2) members of the public.

Term Length:

2 years
